Summary of changes: VAT on a range of domestic energy efficiency and renewable energy installations, including solar, is now 0% in Great Britain. This is a reduction from the previous rate of between 5% and 20%. Eligible installations are those included on the Government's list of Energy Saving Measures (ESMs). What does the new VAT policy mean for battery installations? Extension of VAT relief for battery installations. The revised policy extends the scope of VAT relief, previously limited to batteries installed alongside solar panels. It now includes provisions for standalone battery installations and the retrofitting of existing batteries, thus opening a new chapter in energy innovation.
